

## Palatine Township Property Values Released 2022 reassessment continues for Cook County's North Suburbs



Cook County – Cook County Assessor Fritz Kaegi released the initial assessments of residential and commercial properties in Palatine Township on August 22, 2022. Property owners can expect to receive their Reassessment Notice in the mail within the week.

"Values of residential and commercial property in Palatine Township increased since the last reassessment in 2019, said Assessor Kaegi. "Real estate market trends saw home prices rise while rent collections have resumed since the early days of the pandemic."

The Assessor's Office follows a triennial reassessment cycle, which means one-third of the county is reassessed every three years. When a property is reassessed, the property owner is mailed a Reassessment Notice. The Reassessment Notice reflects the **estimated Fair Market Value** based on sales of similar property over the past three years. The notice also contains important information such as property characteristics, neighborhood code, and past assessment information. An increase in a property's

value does not indicate the same increase in the property owner's taxes.

## **Changes in Assessed Value**

Residential assessments are based on recent sale prices of similar properties. The 2021 median sale price for single-family homes in Palatine Township was \$350,000; for condos, the median sale price was \$158,000 and was \$625,000 for small apartment buildings.

The assessor's median market value estimate for single-family homes in 2022 is \$350,000, for condos the median market value is \$147,000 and is \$590,000 for small apartment buildings.

Commercial property assessments are based on the income generated by those properties. Increases in rents and income of commercial property led to increases in their estimated market value. Rent for large multifamily apartment buildings in Palatine ranges from

approximately \$860 to \$1000 with an average vacancy rate of 5% and an average cap rate of 6.2%.

Industrial properties in Palatine Township average \$7.38 per square foot in rent with an average 7.48% vacancy and 8.94% cap rate.

The average rent for standalone commercial properties varies from approximately \$7-21 per square foot with average vacancy of 5-23% and cap rates from 7.5% to 9%.

## **Summary of Assessed Value**

The total assessed value of the township grew 33% due to increases in residential and commercial property values and the construction of new properties in Palatine.

Percentage increases are total increases for that category, not average property increases. If the percentage increase of a Palatine Township property's individual assessment went up less than the total assessed value of 33%, the property could see little change in its property tax bill or even a decline. The full impact of this reassessment on tax bills will be known in late 2023 after all appeals are processed and exemptions are applied.

Palatine Township is the eighth of thirteen townships located in the North Suburbs of Cook County which will be reassessed this year for Tax Year 2022. The Assessor's Office provides detailed residential and commercial reports—including multi-family assessments, detailed studies of residential assessment quality, and commercial data sources and methodology. ## **Appealing Property Assessments**

If the property characteristics listed on an assessment notice are incorrect, or if the estimated market value of a property is significantly more than what it could sell for in the current real estate market, property owners should consider filing an appeal.
